### AIANY BOARD POSITIONS AND ELECTIVE COMMITTEES

#### **BOARD RESPONSIBILITIES**

The AIA New York Chapter Board of Directors manages the business of the Chapter. The following describes the titles and responsibilities of the relevant Chapter Board members. The Chapter Bylaws more fully describe the roles of the Board Officers (indicated by an asterisk\*) and Directors. Board members are knowledgeable in their areas of responsibility, sought by other members and linked to Committees for their expertise. Select Board Officers also serve on the Center for Architecture Board of Trustees, and on its Executive Committee (indicated by a lemniscate∞).

The ability of the Board members to work and communicate effectively with the staff is key to the success of the Chapter. The Board and Committees shall advise staff of all program and advocacy plans and prepare and approve an annual budget.

All communications shall be channeled through the Chapter office.

All Board members are asked to attend a monthly Board meeting and Annual Retreat.

# Open Positions, must be filled:

The First Vice President/President-Elect\*∞ - The First Vice President/President-elect shall possess all the powers and perform all the duties of the President in the event of the absence of the President or of the President's disability, refusal, or failure to act and shall perform such other duties as are properly assigned by the Board of Directors or the President. **Vice President for Public Outreach -** The Vice Presidents shall possess all the powers and perform all the duties of the First Vice President/President-elect as directed by the President in the event of the absence of the First Vice President/President-elect or the First Vice President/President elect's disability, refusal or failure to act. The Vice Presidents shall perform such other duties as are properly assigned the Board of Directors or the President.

The Vice President for Public Outreach stewards the Public Outreach cohort of AIA New York Program Committees via quarterly meetings.

Commitment: 1 year term, option of two reappointments, up to 3 years Nominating Committee has the option to reappoint: Gustavo Rodriguez

Vice President for Professional Development - The Vice Presidents shall possess all the powers and perform all the duties of the First Vice President/President-elect as directed by the President in the event of the absence of the First Vice President/President-elect or the First Vice President/President elect's disability, refusal or failure to act. The Vice Presidents shall perform such other duties as are properly assigned the Board of Directors or the President.

The Vice President for Professional Development stewards the Professional Development cohort of AIA New York Program Committees via quarterly meetings.

Commitment: 1 year term, option of two reappointments, up to 3 years Nominating Committee has the option to reappoint: Peter Miller

**Secretary** - The Secretary shall act as the recording and corresponding secretary of the Chapter and the Board of Directors, and shall attend all their meetings and keep minutes of the proceedings; have custody of and shall safeguard and keep in good order all property of this Chapter, except property that is placed under the charge of the Treasurer; prepare the reports of the Board of Directors and this Chapter; in collaboration with the President, have charge of all matters pertaining to the meetings of this Chapter, and shall perform all other duties usual and incidental to the office.

Commitment: 1 year term, option of two reappointments, up to 3 years Nominating Committee has the option to reappoint: Kirsten Sibilia

**Treasurer** - The Treasurer shall have charge and shall exercise general supervision of the financial affairs and provide direction to the Director of Finance, an employee of the Chapter, to keep the records and books of account of this Chapter; prepare the budgets, collect amounts due this Chapter, and give receipts for and have the custody of its funds and monies and make all disbursements of funds; have custody of its securities and of its instruments and papers involving finances and financial commitments; conduct the correspondence relating to the office; and perform all duties usual and incidental to the office.

**Director –** Board position for AIA members.

Commitment: 2-year term, with option to reappoint twice (4 years max); regular Board meetings

**Public Director and Oculus Advisor** – Board position for non-AIA members.

**Public Director (for Educational Affairs)**— responsible for developing and maintaining active relationships, and student membership development strategy and implementation with New York area and regional architecture schools.

**Student Director**— a student selected from the area Schools of Architecture and in accordance with the rules of the Board.

Commitment: 1 year term, rotating area schools

#### **Honors Committee**

This committee shall present nominations to the Board of Directors for approval. Nomination shall include but not be limited to: Chapter awards; the Association awards; Institute Honors and Awards; and of other public awards as solicited and decided by the Honors Committee.

### 3 new <u>members per year.</u>

Commitment: 2 year term. 2-3 meetings Jan-Feb; monthly meetings approx. Apr-Sept.

### **Design Awards Committee**

The committee, working with the Chapter Board of Directors and chapter staff, shall organize the annual Design Awards Program.

# 4 new members per year.

Commitment: 1 year term. Meetings begin right after Annual Meeting (June/July). Meets biweekly over the summer. Cannot submit their work to AIANY Design Awards.

#### **Fellows Committee**

This committee shall follow applicable procedures of the Institute, regarding eligibility and nomination procedures for advancement of a member to fellowship and shall follow an appropriate method of communicating such information to all Chapter members. *4 new members for 2026. 2 must be FAIA and 2 do not have to be FAIA.* 

Commitment: 3-year term for FAIAs; 2-year term for FAIA optional positions, option for 1 reappointment. Biweekly meetings Jan-May. Workshop in late spring; two long meetings in summer, monthly meeting in fall; fellowship application reviews.

Nominating Committee has the option to reappoint: Magali Regis, AIA, and Annya Ramirez- Jimenez, AIA

#### **Joint Finance Committee**

This committee shall: assist the President and Treasurer in preparing an annual budget; arrange for audits of the books of this Chapter and report to the Board of Directors the results of such audits; examine, at the direction of the Board of Directors or the Treasurer, the accounts of this Chapter; supervise the investments, trust funds and endowments of this Chapter; and recommend to the Board of Directors appropriate action to be taken thereon.

Commitment: 3-year term. Monthly-ish meetings all year.

#### **Oculus Committee**

This committee meets monthly with the staff of *Oculus* to advise, direct, and set policy and editorial content for the Chapter's publications and web site.
